APPLICATION FOR THE CONSENT OF PROPOSED ROTHES III WIND FARM, NEAR UPPER ROTHES VILLAGE, MORAY UNDER THE ELECTRICITY ACT 1989 AND DEEMED CONSENT UNDER THE TOWN AND COUNTRY PLANNING (SCOTLAND) ACT 1997. THE ENVIRONMENTAL IMPACT ASSESSMENT REPORT IS PREPARED UNDER THE ELECTRICITY WORKS (ENVIRONMENTAL IMPACT ASSESSMENT) (SCOTLAND) REGULATIONS 2017.

Natural Power, on behalf of Rothes III Limited (a wholly owned subsidiary company of Fred.Olsen Renewables Ltd) are sending this letter as formal notification to apply for consent for the proposed Rothes III Wind Farm located near Rothes village in Moray under the Electricity Act 1989 and for deemed planning consent under the Town and Country Planning (Scotland) Act 1997. The Environmental Impact Assessment Report has been prepared under The Electricity Works (Environmental Impact Assessment) (Scotland) Regulations 2017. It is proposed that, as far as is practical, the planning conditions that applied to the Rothes II Wind Farm consent in 2010 (Appendix 1.3 of the EIAR) should also be applied to the proposed development (if consented). This will ensure that there is, in general, duplicate sets of similar conditions applying to the wind farm as a whole with the new set recognising the use of shared infrastructure for the lifetime of the new phase of development.
