Notice is hereby given that Fred. Olsen Renewables Limited, company registration number 13633932 with its Registered Office at 2nd Floor, 36 Broadway, London, United Kingdom, SW1H OBH, has applied to the Scottish Ministers for consent under Section 36 of the Electricity Act 1989 to construct and operate a wind farm known as Scawd Law Wind Farm, Scottish Borders (Central Grid Reference NT371402). The installed capacity of the proposed generating station would be approximately 60 MW - comprising 8 turbines, with a maximum blade tip of 180 metres, and on-site energy storage system of around 12 MW - and has been subject to Environmental Impact Assessment (EIA). An EIA Report has been produced to accompany the application for consent.

The Company has also asked that Scottish Ministers give a direction under section 57(2) of the Town and Country Planning (Scotland) Act 1997 that planning permission for the development be deemed to be granted.

- Consent the proposal, with or without conditions attached; or
- Reject the proposal
