Summary

This Cultural Heritage assessment was undertaken in response to a Section 36C Application for a proposed tip height extension to 3 no. wind turbines within the consented Rothes III wind farm.

This report and accompanying site visit confirmed that there will be a Negligible Magnitude of Impact and a Negligible Significance of Effect upon previously assessed Cultural Heritage assets as a result of the proposed tip height extension. Further, there are no additional Cultural Heritage Assets requiring assessment as a result of the proposed tip height extension.



Background




Figure 1. Location Plan

The proposed development is in respect of the Consented Rothes III wind farm with a generating capacity exceeding 50 MW, located approximately 4 kilometres to the west of Rothes village and just over 2.5 kilometres north of the village of Archiestown in Moray. This application is for the increase in tip height of 3 no turbines from an overall height not exceeding 149.9m to an overall height from base to tip not exceeding 200m (Turbines 9, 13 and 14, Figure 1).

This assessment has been carried out to identify whether there would be an impact upon the Cultural Heritage resource as a result of the proposed tip height extension. The statement was produced by Ms Amy Talbot at Locogen which assessed the heritage assets undertaken on the consented development and confirmed there would be no change to the previously assessed assets as a result of the proposed tip height extension. A copy of Ms Talbot's CV is included in Appendix 11.

The process utilised the updated Zone of Theoretical Visibility (ZTV), and a site visit. The updated ZTV used is the 'Figure 2.2 Comparative Blade Tip ZTV' as depicted in the supporting Landscape and Visual Assessment Document (June 2024)' submitted as part of this application.

The assessment was undertaken in-line with the following standards and guidance:

Statement of Impact

An updated ZTV was provided by Pegasus based on the proposed tip height extension of Turbines 9, 13 and 14. The colour purple in the updated ZTV depicts areas that could undergo visibility as a result of the tip height extension.

As ZTV's are indicative tools for potential visibility, the site visit was undertaken in February 2024 to visit to complement the original application assessment and methodology (Hastie 2018). The site visit confirmed there would be no impact on the Cultural Heritage assets as a result of the tip height extension.

The 42 Cultural Heritage assets, as outlined in the document titled 'EIAR Appendix 9.2 Cultural Heritage Assets within the Outer Study Area' are outlined in Table 1 (Appendix A) below. These were checked against the updated ZTV and confirmed on the site visit.

The consultee comments summarised below are from the original application. These confirm that the assessment provided an appropriate level of assessment of the assets in the Study Areas.

Aberdeenshire Council Archaeology Service (ACAS, 16/04/2029) did not object to the original proposal, subject to a condition, setting out a programme of archaeological works within the Inner Study Area (proposal application site). They made no comment regarding the Cultural Heritage Assets within the Outer Study Area.

Historic Environment Scotland (HES, 21/03/2019) did not object to the original proposal. HES's remit is world heritage sites, scheduled monuments and their setting, category A-listed buildings and their setting, and gardens and designed landscapes (GDLs) and battlefields in their respective inventories. HES were content with the visualisations provided for Rothes Castle (SM2444), Knockando House, Church 300m SSW of (SM2749) and Knockando Churchyard, 500m E of Upper Knockando, three carved stones (SM1225).

HES confirmed they were satisfied the original proposal did not raise issues of national significance for their historic environmental interests.

This assessment, based on the ZTV and supported by the site visit concluded that there would be no additional significant cumulative effects nor intensification of effects arising from the proposed development on the assets assessed and considered for the application of the Consented Development. Further, there are no additional assets requiring assessment and consideration as a result of the proposed tip height extension.
