Application under Section 36C of the Electricity Act 1989 to Vary the Consent Issued by the Scottish Ministers dated the 21st of October 2022 (ECU00000474) relating to Rothes III Wind Farm ("the Consent")

Dear Sir/Madam,

Further to our previous discussions and correspondence with Debbie Flaherty in relation to the above, please accept this letter and supporting documents as the application under Section 36c of The Electricity Act 1989 (Electricity Act), in accordance with the Electricity Generating Stations (Applications for Variation of Consent) (Scotland) Regulations 2013 ("the 2013 Regulation") for a Variation to the Consent made on behalf of Rothes III Limited, with company registration number SC307540 ("the applicant") dated the 21st of October 2022.

The proposed variation (ref: ECU00005150) is in respect of the Consent for Rothes III with a generating capacity exceeding 50MW, located approximately 4 kilometres to the west of Rothes village and just over 2.5 kilometres north of the village of Archiestown in Moray. The consented development is for 28 turbines, turbines numbered 9, 13 and 14 will have a maximum tip height of 149.9 metres, turbines numbered 1, 2, 3, 4, 5, 6, 7 and 29 will have a maximum tip height of 200 metres and turbines numbered 8, 10, 11, 12, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27 and 28 which will have a maximum tip height of 225 metres. This Application is to increase of the tip height of 3no turbines (turbines 9, 13 and 14) from an overall height not exceeding 149.9m to an overall height from base to tip not exceeding 200m.

The environmental effects of the proposed variation have been considered as set out in the documents accompanying the Application. It has been found that the change proposed to the authorised development will not have significant effects on the environment. Therefore the development which is the subject of the Application does not fall within the definition of "Schedule 2" Development under the Electricity Works (Environmental Impact Assessment) (Scotland) Regulations 2017, Regulation 2(1) and Schedule 2, Paragraph 2 and is therefore not EIA development.
